

Terms and Conditions: Attendee Participation Agreement

1. Introduction

1.1 These Terms and Conditions (hereinafter referred to as "Agreement") govern the participation of attendees (hereinafter referred to as "Attendee") in the Connect2Career Virtual Career Fair (hereinafter referred to as "Event") organized by Simple-Group 3v3ntd Private Limited (hereinafter referred to as "Event Organizer").

2. Participation

2.1 By registering and participating in the Event, the Attendee agrees to be bound by these Terms and Conditions.

2.2 The Event Organizer reserves the right to accept or reject any application for registration to the Event at its sole discretion.

3. Responsibilities of the Attendee

3.1 The Attendee shall provide accurate and up-to-date information during the registration process and throughout their participation in the Event.

3.2 The Attendee shall conduct themselves in a professional and respectful manner when interacting with exhibitors, organizers, and other attendees during the Event.

3.3 The Attendee shall comply with all applicable laws, regulations, and guidelines during their participation in the Event.

4. Intellectual Property Rights

4.1 The Attendee acknowledges and agrees that all intellectual property rights associated with the Event, including but not limited to trademarks, logos, and promotional materials, belong exclusively to the Event Organizer.

5. Data Protection

5.2 The Attendee's personal data will be handled in accordance with the Privacy Policy outlined below.

6. Liability

6.1 The Event Organizer shall not be liable for any loss, damage, or injury arising out of or in connection with the Attendee's participation in the Event, except in cases of willful misconduct or gross negligence.

7. Termination

7.1 The Event Organizer reserves the right to terminate the Attendee's participation in the Event at any time without prior notice if the Attendee breaches any provision of this Agreement or engages in conduct that is deemed inappropriate or detrimental to the Event.

8. Governing Law and Jurisdiction

8.1 This Agreement shall be governed by and construed in accordance with the laws of Singapore.

8.2 Any dispute arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of Singapore.

9. Miscellaneous

9.1 This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral.

9.2 This Agreement may be amended or modified only in writing and signed by both Parties.

10. Acceptance

10.1 By registering and participating in the Event, the Attendee acknowledges that they have read, understood, and agree to be bound by these Terms and Conditions.

Privacy Policy
