High priority release for August 2024

- Add the ability to check for duplicate entries in BEDD
- Allow for Visit date/time changes in AMER, PCC, and BEDD





#### BEDD v2.0 p10 & AMER v3.0 p16 Upcoming Release

- •Banner color changes based on specific statuses set by site
  - Example: Suicidal Ideation = magenta, Stroke = purple, MI's = blue
- BEDD ESI level color coded
  - Example: 1=Red and 2 = Orange, 3 = Yellow, 4= green and 5= blue
- Patient flags to display in Patient Edit screen and BEDD
- •Actions report to be generated containing information pulled from General Notes section on the Patient Edit screen and from the actions column on BEDD

#### BEDD v2.0 p10 & AMER v3.0 p16 Upcoming Release

- Adding the ability to display providers first name on BEDD
- Change the time display to hour and minutes for better readability
- •Create a Trauma Registry a new field for trauma activation and a corresponding report
- •Changing "Prime" to "Primary" in the discharge section
