Routine physical maintenance exams, including well-woman exams ....	No charge
Well-child preventive exams (through age 23 months) .....	No charge
Routine eye exams with a Plan Optometrist .....	No charge
Urgent care consultations, evaluations, and treatment .....	\$30 per visit
Most physical, occupational, and speech therapy .....	\$30 per visit

**Telehealth Visits**

Primary Care Visits and Non-Physician Specialist Visits by interactive video or telephone .....	<b>You Pay</b> No charge
Physician Specialist Visits by interactive video or telephone .....	No charge

**Outpatient Services**

Outpatient surgery and certain other outpatient procedures .....	<b>You Pay</b> \$100 per procedure
Most immunizations (including the vaccine) .....	No charge
Most X-rays and laboratory tests .....	No charge

**Hospital Inpatient Services**

Room and board, surgery, anesthesia, X-rays, laboratory tests, and drugs .....	<b>You Pay</b> \$250 per admission

Most generic items (Tier 1) at a Plan Pharmacy .....	\$10 for up to a 30-day supply
Most generic (Tier 1) refills through our mail-order service .....	\$20 for up to a 100-day supply
Most brand-name items (Tier 2) at a Plan Pharmacy .....	\$30 for up to a 30-day supply
Most brand-name (Tier 2) refills through our mail-order service .....	\$60 for up to a 100-day supply
Most specialty items (Tier 4) at a Plan Pharmacy .....	30% Coinsurance (not to exceed \$150) for up to a 30-day supply

<b>Home Health Services</b>	<b>You Pay</b>
Home health care (up to 100 visits per Accumulation Period) .....	No charge
<b>Other</b>	<b>You Pay</b>
Hearing aids every 36 months.....	Amount in excess of \$1,000 Allowance for each ear
Skilled nursing facility care (up to 100 days per calendar year).....	No charge
Prosthetic and orthotic devices as described in the <i>EOC</i> .....	No charge
Diagnosis and treatment of infertility and artificial insemination (such as outpatient procedures or laboratory tests) as described in the <i>EOC</i> .....	50% Coinsurance
Assisted reproductive technology ("ART") Services (such as outpatient procedures or laboratory tests) as described in the <i>EOC</i> (two treatment cycle lifetime maximum).....	50% Coinsurance
