### **Continuing Education Information**

The Indian Health Service National Cancer Prevention, Screening, and Care Conference will bring together a cross-section of disciplines and individuals to collaborate, discuss, and collectively identify strategies to address cancer prevention and screening best practices.

#### **Conference Objectives:**

At the end of this activity, the health care team will be able to:

1. Share the IHS Comprehensive Cancer Blueprint to inform effective practices and approaches to enhance cancer prevention, screening, care, and follow-up serving American Indian and Alaska Native populations.
2. Examine challenges that impact cancer survivors and caregivers and identify potential strategies to reduce barriers.
3. Identify and connect with new collaborative partners to strategize approaches to support health and wellness initiatives.
4. Apply the current IHS screening guidelines into practice for early cancer detection and screening.

#### **Target Audience:**

Healthcare teams from IHS, Tribal, and Urban programs, community health providers, and clinicians (Physicians, Nurses, Pharmacists, Social Workers, Dietitians, and all other disciplines).

#### **Guidelines for Continuing Education Credit:**

- There are no fees to participate.
