The RESCCUE Project



In an intervention during a COP27 official <u>side event</u> on *Coordination and Collaboration towards Ocean Blue NDCs* organized by the Global Ocean Forum, the Government of Fiji, World Ocean Network, the Urban Coast Institute of the Monmouth University together with other partners on November 15, Mrs. Stéphanie Bouziges-Eschmann, Secretary General of the French Facility for Global Environment (FFEM), highlighted the <u>RESCCUE project</u> on the restoration of ecosystem services and adaptation to climate change in the Pacific. Coordinated by the Pacific Community and financed by the FFEM with the French Development Agency, the RESCCUE project aimed to build resilience to climate change through integrated coastal management and innovative economic instruments. Implemented at a regional scale with pilot sites in Fiji and Vanuatu, the RESCCUE project was based on three pillars: i) strategic planning; ii) "no regret" solutions; and iii) reversible solutions.

COP27 Live Day on Aquatic Food

On 14 November 2022, the Virtual Ocean Pavilion will host a live day on Aquatic Food, organized by the Food and Agriculture Organization of the United Nations (FAO), One Ocean Hub, and European Bureau for Conservation and Development (EBCD) in collaboration with other partners. It is the first time that we have dedicated a day to aquatic food during a climate conference. The overall purpose of the day is to celebrate and to accelerate climate action coming out of aquatic food systems. It will feature how aquatic food systems are at the core of climate solutions and that blue transformation and climate transition can multiply their contribution to achieving the Paris Agreement goals while protecting human rights, reducing poverty, and ensuring food security. Protecting the lungs of the sea



Seagrass meadows are one of the most valuable ecosystems on the planet. They absorb up to 35 times more carbon than tropical forests, nurture a wealth of marine life and enrich the water with oxygen. Deep within the turquoise coastal waters of southern Turkey lies some of the oldest and most biodiversity-rich seagrass species in the world: Posidonia Oceanica, also known as 'Neptune grass'.

Fauna and Flora International (FFI) and Akdeniz Koruma Derneği (known in English as the Mediterranean Conservation Society) are protecting these irreplaceable underwater meadows through monitoring, research, and patrolling protected areas.

<u>Indigenous Peoples, Traditional Knowledge, and Ocean-Climate Action</u>



Blue Ventures Outreach Media Technician, Symphorien, explains how he uses a variety of media such as films, music videos, radio shows and presentations to teach coastal communities in Madagascar about traditional Vezo knowledge and sustainably managed marine resources.

Don't fail to watch the provocative event "Whose Ocean Is It Anyway? Why Ocean Heritage Matters for Climate Change Mitigation" which highlights the work being done by the Ocean Decade Heritage Network's (ODHN) Cultural Heritage Framework Programme (CHFP), an official Action of the UN Decade of Ocean Science for Sustainable Development 2021-2030, and the only Action that addresses cultural heritage in the marine sphere.




A KEY MESSAGE FOR EVERYONE: We must protect the ocean and value ocean cultures as sources of knowledge for change.

Advancing ocean action under the UNFCCC: Steps and Recommendations

IUCN, Conservation International, and partners have updated their <u>paper</u> on "Options for strengthening action on the ocean and coasts under the UNFCCC." This options paper summarizes some of the key entry points within existing UNFCCC processes and ongoing negotiations where management actions concerning coastal and marine ecosystems can play a productive role in climate action. The paper identifies specific steps and recommendations for advancing ocean action under the UNFCCC, in response to the invitation for "relevant work programs and constituted bodies under the UNFCCC to consider how to integrate and strengthen ocean-based action in their existing mandates and work plans and to report on these activities within the existing reporting processes, as appropriate" (1/CP.26).



Take a dive into the OCÉAN Exhibition!

A Masterclass on Climate Negotiations

Young people are critically underrepresented in international climate negotiations, notably the UNFCCC Conference of the Parties. The importance of the meaningful engagement of youth in these fora must be highlighted. The inclusion of youth in combating the climate crisis is paramount as active participation is necessary to climate diplomacy that involves all voices.


A live session was held last Saturday, 15 October 2022, where expert speakers experienced in climate negotiations shared tips and tools to prepare youth for climate negotiations. Prior to this session, a Masterclass training was held on October 8-9, 2022, where a toolkit on climate negotiations was developed.

Lloyd's Register Foundation: Keeping Fishers Safe at Sea

Too many people lose their lives at sea, are injured, or face significant safety challenges through the work they do, or where they live. As the ocean economy doubles in the next ten years, these risks grow even greater. Lloyd's Register Foundation is a global safety charity with a mission to engineer a safer world - and that includes a safer ocean.

As well as grant funding safety at sea programmes, the Foundation collaborates with partners around the world to raise awareness of ocean-related safety challenges with a view to driving positive change.



Seen at the booth is the link to the film "Two Kinds of Water" (see the trailer here). This is a film demonstrating the life and struggles of a young couple in Saint Louis, Senegal, West Africa. The couple lives in one of the most vulnerable fishing communities in West Africa. Despite the consistent challenge, tragedy, and hardship, they continue to fish to keep their small family alive. In the words of a man from the community in the film, "There isn't a family on this coast that hasn't mourned loved ones taken by the sea". It illustrates that fishers need to be helped, as they are often in danger. Around 32,000 fatalities occur each year from fishing according to conservative estimates by the FAO in 2020. Many of the fishers are under-equipped, young, weak, and fighting factors out of their control. These include safety challenges like other vessels, climate complications, and everyday struggles that they are forced to face. It notes the story of these individuals both praising the ocean for giving them their occupation, sustenance, and money, all while being afraid of losing their life to it one day.

The film was produced by Dan McDougall from Miran Media. Dan is an award-winning Film Director, Writer and British Foreign Correspondent of the Year who has reported overtly and covertly from over 126 countries, including some of the most hostile environments in the world. He is a Media Leader at the World Economic Forum, lectures in Human Rights Storytelling at Cambridge University, and sits on the International Board of Waterbear, the world's first dedicated climate storytelling platform.

COP27 Virtual Ocean Pavilion Opening Event: Raising Action: An Ocean of Prospects and Opportunities in 2022 and Beyond (30 August 2022)

This event served the Africa Climate Week (<u>ACW</u>) purpose of providing a platform for strengthening government, intergovernmental, and stakeholder response to climate change. It aimed to discuss the prospects and opportunities presented by major ocean events in 2022 and global initiatives of the decade in raising action, ambition, unity, and finance to support innovative and collaborative approaches to mitigate and adapt to the adverse impacts of climate change and for climate-resilient development.
