What is the Electronic CHEF Application Tool?

The Electronic CHEF Application is a fully automated paperless process for identifying, documenting, and submitting requests for reimbursement from the Catastrophic Emergency Health Fund.

Application Objectives

- Create a “one-stop-shop” electronic tool for Catastrophic Health Emergency Fund (CHEF) case processing, capable of tracking each request through the routing process, from creation to Indian Health Service (IHS) Headquarters for potential funding.
- Provide a tool available to both Resource and Patient Management System (RPMS) and non-RPMS users.
- Maintain the integrity of the First In First Out (FIFO) policy for reviewing and processing Purchased/Referred Care (PRC) CHEF cases.



Who Can Use the Electronic CHEF Application Tool?

- **RPMS database users**
 - Federal
 - Tribal
- **Non-RPMS user who choose to provide an electronic data source**
 - Other database
 - Comma Separated Value (csv) text file
- **Any user who wishes to manually enter the appropriate data**



Application Features

- Uses a secure encrypted connection (https)
- Uses HHS PIV card (Government Badge) authentication for federal employees and username/password credentials for non-federal employees
- Uses existing RPMS data and Fiscal Intermediary payment details, when available OR can use an alternate data source of properly formatted data



More Application Features

- Auto generates a 90 day or 90+ day episode of care (EOC) period
- Suggested EOC documents are highlighted for easy identification/best case scenario selection option
- Supports “what if” case analysis by providing a way to change the EOC dates. Option allows assessment for best CHEF case submissions
- Auto generates the case request numbers by fiscal year, Area, PRC program, and sequence number



Even More Application Features

- Electronic copies of supporting documents can be uploaded and “attached” to the applicable CHEF case
- Cases are routed for review and approval using electronic signatures
- Electronic signature timestamps are used to maintain the integrity of First In First Out (FIFO) processing of CHEF cases



Major Application Actions

- Create New Request
- Edit Existing Request
- Supplement Existing Request
- Upload Supporting Documentation
- Cancel a Request
- View Requests
- Export Requests to Excel
- Refresh Window
- Close Window



Let's Talk About Connectivity Options

“Where oh where does the data come from?”



Connectivity option #1

Connectivity with an RPMS system

- Uses a special Object Class enabled File Manger global
- Uses Task Manager scheduled task to populate the global
- Use a restricted Ensemble user account to access the global data via a remote SQL query



Connectivity option #2

Connectivity using a non-RPMS data source:

- Comma-Separated Value (CSV) file—data source description and instructions available for non-RPMS PRC programs. **This type of connectivity will provide full application integration to the Electronic CHEF Application.**
- Microsoft SQL database—data source description and instructions available non-RPMS programs. **This type of connectivity will provide full application integration to the Electronic CHEF Application.**



Connectivity Option #3

Manual Data Entry –An option exists for programs to submit cases without creating data source connectivity to the Electronic CHEF Application.

- **Note:** The submitting location is solely accountable for creating the CHEF case, as well as the accuracy and contents of the data file/CHEF case.
